PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Blazers Ticket Sweepstakes (“Sweepstakes”) will begin on November 26, 2018 at 8:00 A.M. PT and end on April 3, 2019 at 11:59 P.M. PT (“Sweepstakes Period”). All times in the Sweepstakes refer to Pacific Time (“PT”). Odds of winning depend upon the number of eligible Entries (as defined below) received. Sweepstakes is subject to all applicable federal, state and local laws. **PRIZES (DEFINED BELOW) DO NOT INCLUDE ACCOMMODATIONS, TRANSPORTATION, OR PARKING.**

ELIGIBILITY: Open only to permanent, legal United States residents who are physically residing in Oregon or Washington, and who are eighteen (18) years of age or older as of the start of the Sweepstakes Period. Event 1, Event 2, Event 3, Event 4, Event 5, Event 6, Event 7, Event 8, Event 9, Event 10, Event 11, Event 12, Event 13, Event 14, Event 15, Event 16, Event 17, Event 18, Event 19, and Event 20 may be collectively referred to as “Event” or “Events.”

Prizes will be awarded “as is” with no warranty or guarantee, either express or implied, by Sponsors. Prizes may be subject to certain terms and conditions, as specified by issuer. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
