Official Rules
November 6, 2019 — April 7, 2020

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Predict the Game promotion (“Promotion”) will begin on November 6, 2019 at 7:00 P.M. ET and end on or about April 7, 2020 at 11:59 P.M. ET (“Promotion Period”). All times in the Promotion refer to Eastern Time (“ET”). Odds of winning depend upon the number of eligible Entries (defined below) received. Promotion is subject all applicable federal, state and local laws.

ELIGIBILITY: Open only to permanent, legal United States residents who are physically residing in one (1) of the fifty (50) United States or the District of Columbia (excluding Puerto Rico, Guam, the Virgin Islands and other United States territories), and who are eighteen (18) years of age or older and of the age of majority in their state of residence as of the start of the Promotion Period. Officers, directors, and employees of Promotion Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and each of their respective spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Promotion. Each individual Contest will be conducted between and among the eligible entrants to each such Contest. *Each Wizards Game is scheduled to start at or about 7:00 P.M. ET on each of the Wizards Game Dates in the chart above, unless noted otherwise.

During each Entry Period, various questions asking entrants to predict outcomes, statistics, gameplay and/or results relating to the applicable Wizards Game (“Questions”) will appear on the Website (defined below) throughout such Entry Period. To enter a Contest, visit www.nbcsportswashington.com/predict (the “Website”) and follow the provided instructions to log in or create a free account for the Promotion (“Account”), which includes providing your full name, email address, username and password. Then, during an Entry Period, follow the provided instructions to submit your Answers to the Questions that appear on the Website during the applicable Entry Period (the “Entry”). **Limit one (1) Account per person.**

Exact start and end times of each Entry Period will be determined by Sponsors in their sole discretion, depending on the start and end time of each applicable Quarter. Dates and/or times of Wizards Games, Entry Periods, and Quarters are subject to change. If no Quarter is played, no corresponding Contest will be conducted, and no Prizes will be awarded for such corresponding Contest. All Entries become the property of Sponsors and will not be acknowledged or returned. **If you choose to submit your Entry via your web-enabled mobile device, data rates may apply. If, at any time, you no longer wish to receive materials from Sponsors or our partners, please go to our privacy policy, located at Sponsors, or the applicable partner’s privacy policy and follow the procedures indicated.

WINNER DETERMINATION AND NOTIFICATION: For each Contest, entrants will be awarded certain points (“Points”) for the Entries submitted during the corresponding Entry Period, as further provided on the Website. Points will potentially be awarded for (i) each Answer submitted and (ii) each Answer submitted that correctly answers the corresponding Question. The number of potential Points awarded may vary by Question. Whether an Answer is

correct will be based on the outcome, statistics, gameplay, and/or results of the applicable Wizards Game (as determined by Sponsors in their sole discretion). At or about the conclusion of the applicable Entry Period, Sponsors will review all eligible Entries received during such Entry Period. For each Entry Period, the eligible entrant who received the most Points relative to the other entrants, as determined by Sponsors in their sole discretion, will be deemed the potential winner of the corresponding Contest (each a “Winner”), subject to verification of eligibility. In the event multiple eligible entrants tie for the most Points received for an Entry Period, each such eligible entrant will be deemed a potential Winner of the corresponding Contest and the applicable Contest Prize (defined below) will be evenly split amongst such potential Winners, subject to verification of eligibility.

The results of each Contest will be based on the outcome, statistics, gameplay, and/or results of the applicable Wizards Game as of the time when Entries are reviewed and final scoring is tabulated by Sponsors. Contest results will not be changed in light of official adjustments made by the professional leagues, though Sponsors reserve the right to make adjustments to Contest results based on errors or irregularities in their calculation of results or in the transmission of information to Sponsors from third parties. Sponsors have no obligation to delay the awarding of any prize in anticipation of any adjustment, and Sponsors reserve the right to reverse the awarding of any prize in the event of any adjustment. Entrants agree to be bound by any such adjustments and to cooperate with Sponsors’ reasonable efforts to award prizes. **Decisions of Sponsors are final and binding with respect to all matters related to the Promotion. ADDITIONAL TERMS: Sponsors reserve the right to permanently disqualify from any promotion any person they believe has intentionally violated these Official Rules. Any attempt to deliberately damage the Promotion or the operation thereof is unlawful and subject to legal action by Sponsors, who may seek damages to the fullest extent permitted by law. The failure of Sponsors to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsors (excepting compliance with applicable codes and regulations), or other “force majeure” event will not be considered a breach of these Official Rules. Released Parties assume no responsibility for any injury or damage to entrants’ or to any other person’s computer relating to or resulting from entering or downloading materials or software in connection with the Promotion. Released Parties are not responsible for telecommunications, network, electronic, technical, or computer failures of any kind; for inaccurate transcription of entry information; for errors in any promotional or marketing materials or in these Official Rules; for any human or electronic error; or for Entries that are stolen, misdirected, garbled, delayed, lost, late, damaged, or returned. Sponsors do not warrant or make any representations of any kind with respect to the information provided through the Website, including, without limitation, Live Information, and Sponsors shall not be responsible or liable for the accuracy, usefulness, or availability of such information, or for any errors or omissions in connection therewith. **Sponsors reserve the right to cancel, modify, or suspend the Promotion or any element thereof (including, without limitation, any Contest and/or these Official Rules) without notice in any manner and for any reason (including, without limitation, in the event of any unanticipated occurrence that is not fully addressed in these Official Rules).** In the event of cancellation, modification, or suspension, Sponsors reserve the right to select Winners in a random drawing from among all eligible, non-suspect Entries received prior to the time of the event warranting such cancellation, modification, or suspension. Notice of such cancellation, modification, or suspension will be posted on the Website. Sponsors may prohibit any entrant or potential entrant from participating in the Promotion, void any Entries submitted by such entrant or potential entrant, or disqualify such entrant or potential entrant from the Promotion if such entrant or potential entrant engages in any conduct Sponsors, in their sole discretion, determine to be improper, unfair, fraudulent or otherwise adverse to the operation of the Promotion or in any way detrimental to other entrants or potential entrants (“Improper Conduct”). If any entrant or potential entrant engages in any Improper Conduct (as determined by Sponsors in their sole discretion), Prizes may be delayed, withheld and/or forfeited, and Sponsors may require the return of any Prizes that have already been awarded. Sponsor reserves the

right to modify these rules for clarification purposes without materially affecting the terms and conditions of the Promotion.

DISPUTES: THE PROMOTION IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN NEW YORK, NEW YORK. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JUDICIAL ARBITRATION AND MEDIATION SERVICES, INC., IN ACCORDANCE WITH ITS STREAMLINED ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
